### **Vendor Information**

1. Vendor booth size is 12' X 12'. \$25.00 fee for initial booth. \$5.00 fee for each additional 12' X 12' space required.
2. All vendor fees must be paid by 9:00 am Saturday September 12<sup>th</sup>.
3. Vendor booth setup will be on Friday September 11<sup>th</sup> from 6:00 pm until 10:00 pm, or Saturday September 12<sup>th</sup> from 5:00 am until 8:30 am. All vendors must be set up and ready for operations by 9:00. Vehicle traffic in Dillon Park will be stopped at 8:30 am due to safety of our riders.
4. Vendors will be assigned a booth location by the vendor coordinator.
5. Vendors agree to keep booth open from 9:00 am until 5:00 pm. Any early booth breakdown must be approved by the vendor coordinator.
6. All vendor booths must be disassembled and removed by 12:00 am, Sunday September 13<sup>th</sup>.
7. Food Vendor will deal directly with the Cannon County Health Department concerning, but not limited too; food preparation, food delivery, and selling food to the public.
8. Vendors are encouraged and responsible for carrying their own insurance coverage concerning booth operations, merchandise, food, content, employee actions, and liability, etc.
9. Vendors are responsible for collection and/or payment of any applicable local, state and federal taxes.
10. Vendors are responsible for proving chairs, tables, power cords, and any other equipment required for booth operations. Electricity and running water will be provided at the event, at no additional charge.
11. Although security will be provided, the Cannon County Rescue Squad, Inc., city of Woodbury and Cannon County will not be responsible for any loss, theft, damage, breakage, injuries, or food borne illnesses.
